Continuing Independent Series and Programming means series and programming that began prior to January 18, 2011 but ends on or after January 18, 2011.

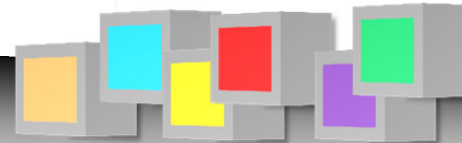
New Independent Series and Programming means series and programming renewed or picked up on or after January 18, 2011 or that were not on the network prior to January 18, 2011.
